# **Insight**<sup>®</sup>EQA CURRENT PRICES



#### The current standard prices to register for InSight EQA are:

Cycle runs from 1st April - 31st March in any given year.

Prices are reduced pro-rata for practices joining midway through the cycle.

- Biochemistry only at a single site (up to 4 analysers): £200+VAT/year
- Haematology only at a single site (1 analyser): £200+VAT/year
- Biochemistry and Haematology at a single site (up to 4 Biochemistry and 1 Haematology analyser): £300+VAT/year
- Blood Coagulation: £45+VAT/year
- Urine Chemistry: £12+VAT/year

Note that if a practice has a biochemistry analyser and a separate electrolyte analyser at the same address, for charging purposes they are considered as one analyser, although separate reports will be issued for each analyser.

However, if samples are posted to a practice and they choose not to return results that month, no credit will be provided.
